All exhibits must be in position before **8.30 am on Show day** and must not be loaded on to transport or removed from the showground **before 5-30pm and then only** if the show organisers have allowed movement. Movement of vehicles **IS NOT** permitted within the showground between these times without authorisation from the show management. **Note** the Show organisers may extend the **NO MOVEMENT TIME** if an unforeseen circumstance occurs.

Please ensure that your vehicle is disabled whilst on display to ensure that no-one can move your vehicle other than yourself.

Moving an exhibit into the show ring requires the exhibit to be insured, registered with the DVLA and have public liability insurance.

You will need to register your exhibit with the exhibit steward of NVTEC (North Somerset Group) on arrival at the display area.

If you are unable to display your exhibit the entry tickets and vehicle pass will need to be returned to the exhibit steward below, either previous to the show or within a week following the show. Failure to return tickets will make full reimbursement of the ticket(s) entry price.
